## **Findings**

Lived experiences of persons with disabilities in Namibia

#### **Sub-Themes (Child Nodes):**

- The new mall is a joke
- The policy is a paper thing
- We are also citizens
- Barriers to occupational participation
- Barriers to accessing services

Theme(Parent Node):

The struggle is real

'The hardest moments for me were not when people challenged what I said, but when I felt my voice was not heard..' [CIT4]

Perspectives of policy-makers on the lives of persons with disabilities

#### **Sub-themes (Child Nodes):**

- Persons with disabilities are self-limiting
- Luke-warm fluidic policy environment
- No ownership of current disability policy

#### Theme(Parent Node):

It's not too bad- perspectives from positions of power

'My view is that lives of persons with disabilities in Namibia is not too bad, for me it's a better situation.

We see more people with disabilities employed, I may not have the data to substantiate this but we see more people getting employed.' [KI5]

Perspectives of occupational therapists on the lives of persons with disabilities

#### **Sub-themes (Child Nodes):**

- Need for a voice from persons with disabilities themselves.
- Occupational therapists as change agents for occupational justice.

#### Theme (Parent Node):

Persons with disabilities: a constituency in need

'I will tell the policy makers to take one child with disability in a wheelchair and spend the whole day with that child moving around the city using taxis, getting an appropriate school for the child, feeding the child and doing everything. So that they can address the needs for such children in the policy'. [IFG6]

## Embedded forms of occupational injustice

- Occupational marginalization
- Occupational deprivation
- Occupational alienation
- Occupational inconsideration
- Occupational participation barriers identified ...... attitudinal, access, physical, expertise and systemic.

## Suggested disability policy reforms

- Persons with disabilities -- 10 suggestions
- Occupational Therapists— 13 suggestions
- Decision makers— 8 suggestions
- 4 suggestions were consistently mentioned by all participant groups:
  - Awareness raising on rights of persons with disabilities
  - Access to information for general community development
  - Accessible education infrastructure
  - Inclusive vocational skills training
