



TERMS AND CONDITIONS

To qualify for early bird registration, registration fees must be paid in full by the early bird deadline of 23 June 2022. Registration fees received after this date will revert back to the standard Congress applicable rate. Registration fees are based on date of payment receipt, not the date of receipt of registration form.

After 5 August 2022 midnight GMT+2 (Paris time), only payment made by credit card will be accepted.

The Congress is committed to the health and safety of our attendees, sponsors and exhibitors, your communities and our industry. In the event of travel bans, border closures, restrictions on large gatherings, or other impacts due to Covid-19 pandemic or other conditions, the Congress will move from a hybrid event to a virtual Congress or change dates.

If moved to a virtual Congress the difference in registration rates will be refunded. In the case that the attendee does not wish to attend the Congress virtually, no full refunds will be given, only the difference in the fee will be refunded.

By registering to attend the Congress, you accept these conditions.

CANCELLATION CONDITIONS

If the Congress is proceeding as a hybrid event, a request to convert to a virtual registration from a full registration will receive a refund of the difference if advised via email by Friday 29 July 2022 midnight GMT+2 (Paris time).

Cancellations received in writing to the Congress Office by Friday 29 July 2022 midnight GMT+2 (Paris time) will be accepted and all fees refunded less an administrative fee of 100€ for high-income registrations, 50€ for low-income registrations or 25€ for registrations where the total cost does not exceed 250€. Cancellations or requests to change registration type received after this date cannot be accepted and will not be refunded (in part or full).

If your application for a visa to enter France is unsuccessful, the above cancellation terms apply.

Non-attendance: No refunds will be made for non-attendance at the Congress.

Transfer of registration

Should you purchase an in-person registration and then later need to transfer to a virtual ticket type or wish to transfer a virtual registration to an in-person registration you may do so **once** per registration at no cost before Friday 29 July 2022 midnight GMT+2 (Paris time). You will be charged the additional amount, or refunded the difference in ticket cost for the equivalent registration type (i.e. if you had purchased your ticket at the early bird rate, you will be transferred to the equivalent ticket at the early bird rate). Any additional registration transfers after the first or transfers made after Friday 29 July 2022 will incur an admin fee of 25€.

Transfer of your registration to another person within your organisation is acceptable. The full name and details of the person that will replace you must be advised in writing to the Congress Office prior to the Congress.

Congress Cancellation by World Federation of Occupational Therapists Congress 2022

It may be necessary for reasons beyond the control of World Federation of Occupational Therapists Congress 2022 (WFOT 2022) to alter the times, dates, itineraries or speakers of the Congress by notice to you at any time. In the unlikely event of cancellation of the Congress, the maximum liability of WFOT 2022 is the full amount of the refund of the Congress registration fee and its associated components of attendance with no additional liability for travel costs, hotel costs, or any other costs or expenses whatsoever.

In the unlikely event of cancellation or postponement of the Congress due to circumstances beyond WFOT 2022 reasonable control including but not limited to, acts of terrorism, war, acts of God and natural disaster or

global health crisis, WFOT 2022 or Think Business Events cannot be held responsible for any cost, damage or expense which may be incurred by registrants as a consequence of the event being postponed or cancelled.

Member registration fees:

To qualify for the Member Rate, you must be an individual member of WFOT, or a member of a national association that is a member organisation of WFOT. Your membership status will be verified by the relevant Association. [Click here](#) for details of which national associations are WFOT members.

Student Rate:

The Student Rate applies to those who are a student at the time of registration and the Congress period. Students are those studying in an entry level education programme to become an occupational therapist, or qualified occupational therapists who are undertaking full time doctoral studies or similar post entry-level education.

Processing time for bank refunds: Refunds (less applicable administrative fees) if applicable will be processed no later than 30 days of the conclusion of the Congress. After this date if no bank details have been received by the Congress the refund will be forfeited.

Late Registration

The Congress organisers cannot guarantee that collateral, such as satchels, will be available to late registering attendees (inside one month before the Congress). In addition, there is a risk that social programme functions may be fully subscribed.

GRANT RECIPIENT TERMS AND CONDITIONS

Grant recipients must submit a report within two months of the Congress to WFOT, reporting on their experience and the impact of attending the WFOT Congress (failure to do so may lead to a refund being sought by WFOT). Information provided within these reports may be used by WFOT on its website, social media and in e-newsletters for promotional purposes.

Grant recipients may be required to submit a written report to the journal/newsletter of the funding association as well as any local publication they may have about their attendance and their key learning experiences whilst in Paris.

Grant recipients commit to return to their home country at the end of the Congress, for those attending in person.

Successful candidates will be required to sign an undertaking indicating that any expenses/payments made on their behalf will be repaid if they do not attend the WFOT Congress 2022.

Grant recipients and amounts will be determined by WFOT.

WFOT retains the right to make final decisions regarding the selection of successful candidates.

WFOT is not responsible or liable for Grant recipients during their stay in Paris, if attending in person.

WFOT recommends visa applications are initiated in a timely manner. WFOT does not accept any responsibility or liability for the visa application procedure. Expenses will not be reimbursed until the required visa has been obtained.

WFOT does not accept any liability for damages occurring from or resulting by visiting the WFOT Congress 2022, or during an applicant's stay in Paris. Grant recipients are responsible for their own travel insurance which is recommended to include cover for Covid-19 related costs. WFOT will not be funding quarantine costs.

USE OF PERSONAL INFORMATION

The Congress will collect and store information you provide in this Registration Form for the purposes of enabling us to:

- register your attendance at the Congress;
- assist with administrative and planning purposes;
- plan and develop Congress and other events in the future;
- facilitate your requirements in relation to the Congress; and
- allow the compilation and analysis of statistics relevant to the Congress.

The information that you provide in the Registration Form and information provided at any other time during the Congress, including without limitation any feedback obtained during the Congress, will be used by the Congress to offer, provide and continue to improve its Congress and other services.

To fulfil your request to access the online registration portal you enter into an agreement with WFOT 2022 Congress and we capture and process a set of personal information provided by you. For EU data protection law our lawful basis for processing personal data for this purpose is [Article 6, \(1\)\(b\)](#).

The data that we collect from you is transferred and stored within the United Kingdom (UK), the United States, Australia and other jurisdictions around the world. We will retain your data only for as long as we have a business requirement to do so.

To provide you goods and services, WFOT 2022 Congress works with a range of suppliers. These third parties operate under contract with WFOT 2022 Congress and we will share your information with these parties where it is necessary to deliver the goods and services you have requested.

These suppliers are data processors under data protection law and can only process your information in line with the instructions we provide in their contract. These include specific clauses to protect your personal information. They will not share your personal information with any organisations apart from us. They will hold it securely and retain it for the period we instruct.

In some circumstances we are legally obliged to share information.
